IMPORTANT INFORMATION:

ALL NIGERIAN VISA APPLICANTS ARE REQUIRED TO VISIT THE VISA PROCESSING CENTRE(S) FOR BIOMETRICS WITH ALL REQUIRED DOCUMENTS APPLICABLE FOR THE TYPES OF VISAS.

The jurisdictions of the various Centers are indicated as follows: **New York (O.I.S Services)**, **Washington DC**, **Atlanta or Los Angeles (O.I.S Services)**.

- Appointment is mandatory for every visit at the visa processing center.
 Appointment duration per applicant is 10minutes to avoid overlapping of appointment. Failure to meet up with appointment within the stipulated date will result to appointment cancellation and rescheduling appointment for another day. Please visit: http://www.oisservices.com/home.php
- Children under the age of five (5) and adults over the age of sixty-five (65) are not required to be physically present at the visa Centers. Applicable documents can be mailed to the visa processing Center.
- Applicants should have up to four (4) BLANK PAGES on their passport.
- Passport photographs are NOT required for applicants from ages 5 years to 64 years since their passport photograph will be taken during the biometrics appointment at the Visa Center.
- Those who have had their biometrics taken at the Visa Centre and all their information remain UNCHANGED since they last visited the Centre can mail in their documents and do NOT need to appear physically at the Visa Processing Centre.

For USA Passport holders, the Visa fee is \$160.00

Note: This is an Application fee payable online to the www.innovate1services.com on behalf of the NIGERIA IMMIGRATION SERVICE (NIS).

Note: All holders of ECOWAS member country passports DO NOT require a visa to enter Nigeria.

- Go to Nigeria Immigration Service for commencement of electronic application.
- Select UNITED STATES as processing country

PLEASE READ IN FULL THE GUIDELINES REGARDING PAYMENT

- Click on "START APPLICATION". Choose from GOOGLE, YAHOO or OPEN ID and create an account or if you have one, SIGN IN.

VISA REQUIREMENTS:

DIPLOMATIC AND OFFICIAL PASSPORT HOLDERS

Holders of Diplomatic and official Passports are required to submit all application documents directly to the Consulate General of Nigeria, New York.

- **(1.)** Passport and copy of data page(s) Passports should have a minimum of 6 months validity.
- (2.) Copy of online application form (SIGNED AND DATED)
- (3.) Original copy of Note Verbale.
- **(4.)** 2 passport sized photographs
- **(5.)** Flight Itinerary (at least a copy of a flight booking, showing arrival and departure)

VISA APPLICANT

- **(1.)** Passport and copy of data page(s) Passports should have a minimum of 6 months validity.
- (2.) Copy of online application form (SIGNED AND DATED)
- (3.) Payment and Acknowledgment Slips Printed
- (4.) 2 passport sized photographs

- **(5.)** Flight Itinerary (at least a copy of a flight booking, showing arrival and departure)
- **(6.)** Bank Statement (showing adequate funds)
- **(7.)** A letter of invitation from the host addressed to the Consulate General of Nigeria. It must be on letter headed paper stating the address of the host or organization, the reason for the visit and should be signed and dated.

Note: A holder of an expired Nigerian passport with dual-nationality may submit a copy and will therefore NOT be required to submit items 7-8.

VISITORS AND TOURISTS VISA

Note: Visitor/Tourist visas when issued are valid for a 90-day period of stay from date of entry into Nigeria.

Note: For all visa types listed below, the approved period of stay begins from date of entry, however, applicants will have a period of 90 days from issue to make use of the entry visa after which time, the visa becomes invalid and the applicant will have to reapply. This includes multiple entry visas as per the first entry into the country.

- **(1.)** Passport and copy of data page(s) Passports should have a minimum of 6 months validity.
- **(2.)** Copy of online application form (SIGNED AND DATED)
- (3.) Payment and Acknowledgment Slips Printed
- (4.) 2 passport sized photographs
- **(5.)** Flight Itinerary (at least a copy of a flight booking, showing arrival and departure)
- **(6.)** Bank Statement (showing adequate funds)
- **(7.)** A letter of invitation from the host addressed to the Consulate General of Nigeria. It must be on letter headed paper stating the address of the host or organization, the reason for the visit and should be signed and dated.
- **(8.)** A copy of the host's passport (the data pages including the photograph and signature, for non-Nigerians including the page that shows the host's legal immigration status in Nigeria
- **(9.)** Hotel Reservation

Note: A holder of an expired Nigerian passport with dual-nationality may submit a copy and will therefore NOT be required to submit items 8-10.

BUSINESS / MULTIPLE ENTRY VISA

Multiple entry visas may be considered when applied for and applicants would be required to provide:

- **(1.)** Passport and copy of data page(s) Passports should have a minimum of 6 months validity.
- **(2.)** Copy of online application form (SIGNED AND DATED)
- (3.) Payment and Acknowledgment Slips Printed
- (4.) 2 passport sized photographs
- **(5.)** Flight Itinerary (at least a copy of a flight booking, showing arrival and departure)
- **(6.)** Bank Statement (showing adequate funds) / Letter of undertaking from employer
- **(7.)** Business invitation on business letterhead addressed to the Consulate General of Nigeria. It must be on letter headed paper stating the address of the host organization, the reason for the visit and maybe be signed and dated.
- **(8.)** Certificate of Incorporation (a copy provided by the business in Nigeria government bodies, major banks and oil companies excluded)
- **(9.)** A letter of introduction from the Employer.
- **(10.)** Documentary evidence of need for multiple entry visa.

Note: Travelers on Religious or Journalistic visit fall under the business category BUT will not need to provide item no. 9 above. However, these applications can take up to six (6) weeks to process; applicants should therefore make provision for this and apply early to the relevant Nigerian authorities for clearance.

TRANSIT VISAS

A transit visa is required if an applicant will have need to leave the airport, and therefore enter the country before completing a journey. Please provide:

- **(1.)** Passport and copy of data page(s) Passports should have a minimum of 6 months validity.
- (2.) Copy of online application form (SIGNED AND DATED)
- (3.) Payment and Acknowledgment Slips Printed
- (4.) 2 passport sized photographs

• **(5.)** Flight Itinerary (at least a copy of a flight booking, showing arrival and departure)

MINORS (17 YEARS OLD AND UNDER)

- **(1.)** Passport and copy of data page(s) Passports should have a minimum of 6 months validity.
- **(2.)** Copy of online application form (SIGNED AND DATED)
- (3.) Payment and Acknowledgment Slips Printed
- **(4.)** 2 passport sized photographs
- **(5.)** Flight Itinerary (at least a copy of a flight booking, showing arrival and departure)
- **(7.)** Copies of the child/children's birth certificate. (4 Copies)
- **(8.)** Copies of both parents` valid passport data/signature pages. (4 Copies)

<u>Note:</u>> Signatures and names should match those in their respective passports and names must match those on the birth certificate.

In case where either parent has sole custody, a copy of a legal document should be provided to this effect, and in which case consent need only come from the single parent.

SUBJECT TO REGULARIZATION (STR) VISA APPLICATIONS/LONG TERM EMPLOYMENT

Note: STR Visas are issued with approved stay for a period of two (2) years BUT are renewable in Nigeria (subject to approval).

PRIMARY APPLICANT

- **(1.)** Passport and copy of data page(s) Passports should have a minimum of 6 months validity.
- (2.) Copy of online application form (SIGNED AND DATED)
- (3.) Payment and Acknowledgment Slips Printed
- (4.) 2 passport sized photographs
- **(5.)** Flight Itinerary (at least a copy of a flight booking, showing arrival and departure)
- **(6.)** Copies of the child/children's birth certificate. (4 Copies)

• **(7.)** Copies of both parents` valid passport data/signature pages. (4 Copies)

Note: Standard processing for STR Visa is fourteen (14) business days.

Documents below should be submitted in four (4) duplicate sets and arranged in the following order:

- Page 1 Form (online form) with one (1) colored passport sized photograph (on white background) attached.
- Page 2 Copy of letter of request from the company addressed to the Consulate General of Nigeria requesting STR visa for the applicant, this must contain the applicant's full name.
- Page 3 Copy of expatriate quota stating position of employment
- Page 4 Copy of employment letter stating position employment
- Page 5 Copy of applicant's signed acceptance letter stating position of employment
- Page 6 Copies of qualifications: degree, diploma certificates matching those mentioned on the resume.
- Page 7 Copy of credentials, certificated and curriculum vitae, all vetted by a relevant official of Nigerian High Commission/Embassy (English Certified translated copy where applicable)

Note: Applicants will also need to submit originals of certificates for inspection. Please submit these Enclosed in a separate envelope marked 'ORIGINAL CERTIFICATES'

STR (SPOUSE)

- **(1.)** Passport and copy of data page(s) Passports should have a minimum of 6 months validity.
- **(2.)** Copy of online application form (SIGNED AND DATED)
- (3.) Payment and Acknowledgment Slips Printed
- **(4.)** 2 passport sized photographs

- **(5.)** Flight Itinerary (at least a copy of a flight booking, showing arrival and departure)
- **(6.)** Spouse's Bank Statement (showing adequate funds FOR STRS' A MINIMUM OF \$500 IN CREDIT NO MORE THAN 3 MONTHS OLD AT TIME OF SUBMISSION).

Documents below should be submitted in four (4) duplicate sets + arranged in the following order:

- Page 1 form (online form) with one (1) colored passport sized photograph (on white background) attached.
- Page 2 Copy of letter of request from the company addressed to the Consulate General of Nigeria requesting STR visa for the applicant, this must contain the applicants full name.

TWP VISA REQUIRMENTS

- **(1.)** Passport and copy of data page(s) Passports should have a minimum of 6 months validity.
- **(2.)** Copy of online application form (SIGNED AND DATED)
- (3.) Payment and Acknowledgment Slips Printed
- **(4.)** 2 passport sized photographs
- **(5.)** Flight Itinerary (at least a copy of a flight booking, showing arrival and departure)
- **(6.)** Letter of employment stating position
- **(10.)** Applicant's letter of acceptance.
- (11.) A letter of introduction/invitation stating position from the host organization in Nigeria. This must be addressed to The Consulate General of Nigeria. It must be on letter headed paper stating the address of the host organization, the reason for the visit and must be signed and dated.

• **(12.)** Copy of Comptroller General of Immigration's approval cable visa that lists the applicant's name.

Note: This document is obtained by the employer from the Nigeria Immigration Service in Nigeria on behalf of the employee; the applicant must provide this document when submitting the visa application to the Consulate.
